Moving Home Minnesota	Provides a transition coordinator to support members moving from institutions to their own home in the community.	Connect, Connect + Medicare, MSC+ and MSHO	 MA paying for at least one day of the institutional stay. Maintains enrollment in MA during the time they are eligible to receive MHM services. Desires to transition to a qualified community residence Limitations: Must enroll in Elderly Waiver (or other eligible waiver) upon discharge and use waiver support first. Duplications of Services: May not use MHM, HSS and RSC-TCM at the same time. 	MSC+/MSHO: UCare Medical Assistance Connect/Connect + Medicare: Fee-for- service Medical Assistance	Members may begin the enrollment process to receive MHM transition services during their institutional stay by having anyone complete the online MHM Intake Form (DHS-5032). The intake form can also be mailed or faxed in.
Relocation Service Coordination Targeted Case Management	Case management to help members move out of certain facilities into the community.
